Just a reminder, agri-food systems consume about 30% of the world's energy and a third of agri-food systems' emissions of greenhouse gases stem from energy use. It is no secret that the Russian aggression in Ukraine is impacting the EU agri-food value chain. The shift towards renewable energy is even more urgent in this industrial ecosystem.



What are the funding instruments?

Rural Development support instruments



Investments Investments in the production and processing of agricultural and non-agricultural products and materials,

- plastics, electricity, energy, gas etc.

 Investments in the production of renewable energy (on-farm/off-farm)
- and inter-linked activities

 Investments in improving energy efficiency
- Investments in infrastructure in rural areas

Rural business start-up

- start-up of rural businesses linked to agriculture or forestry
- business start-up of non agricultural activities in rural areas releated to LEADER strategies
- lump sum payment, business plan has to be provided

Cooperation

- Cooperation costs to promote new forms of cooperation between different actors
- LEADER projects based on local development strategies
- European Innovation Partnership (EIP-AGRI)

Knowledge exchange and dissemination of information

- Support for knowledge transfer
- Support for advisory services

Support in the form of grants (up to 100% support possible) or financial instruments



100% support is more linked to cooperation and knowledge activities. 20%-40% support is for investments.

CAP Strategic Plans – shared management



- Single CAP plan for all interventions with a common monitoring system
- Strategic approach based on needs assessment
- Structured dialogue with Member States
- MS draws up and submits the CAP Plan
- CAP Plan is approved by the Commission
- Implementation of the CAP Plans starts in 2023

Next is Blaga Valentinova Popova – team leader in DG GROW



Ms Popova starts with the EU Code of Conduct for Sustainable Food Businesses and marketing practices. The conduct is one of the actions under the Farm to Fork Strategy. It is specifically targeted at the actors between the farm and the fork, and it is a framework with eight aspirational objectives covering all areas of food sustainability, from healthy and sustainable diets and reducing food waste to resource efficiency, carbon neutrality, and social aspects such as decent work and sustainable sourcing. The code of conduct was launched in July 2021.

There was an annual Conduct Signatories meeting, a collaborative platform where the signatories are open to other stakeholders within the agri-food ecosystem, civil society policymakers, and international organisations. They took stock of the progress of this initiative. There are more than 130 signatories to the code of conduct. These companies and associations signed up the code, internalised and adhered to that sustainability objectives. They also made a concrete commitment to the different objectives and reported on their actions last year to meet them. Most of the 130 signatories are large food and drink companies, and retailers, which is excellent, but there are much fewer small companies involved. All signatories also meet and discuss different topics, exchange good practices, and create opportunities for collaboration. One of the objectives under the code is value creation within the food supply chain, which is an essential element.





It is expected to have a specific SME tool linked to the code of conduct by the end of January or February. This tool is to be hosted by the ECCP. It will allow smaller companies to sign up for a simplified The Code by just filling in a form. It will enable companies to evaluate their activities, decide where they stand, and in which area of The Code they could commit and link that to existing best practices within the ERIC database.

Follows panel debate



Ms Kropaite starts with the question about Euroclusters. This question is for Ms Claudia De Oliveira Ramos, International Project and Network Manager, VEGEPOLYS VALLEY.

Ms Kropaite: How would you define Euroclusters, and how can they help accelerate growth, innovation and competitiveness?

Ms Ramos says that Euroclusters helps European SMEs with innovations and questions that organisations face. She positively sees this. Their organisation VEGEPOLYS VALLEY has a Euroclusters project that is about Urban agriculture.





Ms Ramos invites **Ms Pauline Bodin** into this question. She is asked what the main challenges they are facing are. She says that it is the water and energy management of production. There is also a challenge to make an agri-food ecosystem resilient.

Mr Gawel Walczek, International Affairs manager, secpho, is asked about secpho, a technology agri-food cluster. Secpho is a deep tech ecosystem from Spain. What are deep tech technologies? For example, sensors, lasers, robotics, automated vehicles, AI, and big data. Agri-food is one of the sectors on which secpho focuses.

Mr Walczeck is asked what is the main challenge currently. He says that from the technology provider's perspective, it is reaching out the partners from the agri-food sectors. His main challenge is reaching out to the right stakeholders and entities, the right people in the agri-food sector. He believes this is a challenge for other deep tech or technology ecosystems.

Ms Kropaite asks if this means that the agri-food sector is unwilling to cooperate or to be digitalised as any other sector. **Mr Walczeck** believes this isn't a question of will but more about knowledge. The organisations don't know about the possibilities or the deep tech; they don't know what it is. **A lack of information and knowledge causes it.**

Ms Kropaite mentions that this is an exciting and vital point. She asks the next panellist what innovative solutions are currently being developed if we talk about EIT Food. Paola Giavedoni, Director of innovation, EIT Food, starts with the EIT Food introduction. EIT means European Institute of Innovation and Technology. They are the leading initiative in innovation in Europe, and the EU co-founds them. They are a family of eight EITs or knowledge innovation communities. They focus their attention and programs on delivering products to the market. Their principles are based on the knowledge triangle integration. Innovation is a long process.

At the moment, EIT Food works on three big missions. One is the **net and net zero food system, the healthier life through food** – **nutrition and health through nutrition, and the last one is a fully transparent, resilient and fair food system.** They focus on protein diversification (they work on alternative proteins and try to increase proteins from alternative sources) and sustainable agriculture through different programmes.

Ms Yuan Chai, International Affairs Officer, Wagralim, is also asked about Euroclusters and what it is like to bring innovation to the system. They are currently working on the Be resident Euroclusters project, granted under the agri-food trend. This project focuses on reducing gas emissions. They help SMEs be more productive and efficient in production, have better knowledge and help them with the green transition.

Ms Kropaite also asks Ms Chai if she can agree with others regarding the lack of knowledge and, in some cases, lack of internet to adopt novelties and energy management issues. Ms Chai says that SMEs must face several issues this year, such as salary indexations and high energy prices. The main challenge is more about surviving, which is a priority, rather than investing in a green transition. This means that SMEs postponed these activities.
